# **Conflict Incident Monthly Tracker**

# Cross River State: August-September 2017

## Background

This monthly tracker is designed to update Peace Agents on patterns and trends in conflict risk and violence, as identified by the Integrated Peace and Development Unit (IPDU) early warning system, and to seek feedback and input for response to mitigate areas of conflict.

## Patterns and Trends June-August 2017


According to Peace Map data (see Figure 1), there was a decrease in lethal violence in Cross River state in August. Incidents reported during this period included communal violence, criminality, cult violence, and mob violence.

Communal Violence: In June, four were reported killed in a clash over land dispute between Akamkpa and Ojor communities in Akamkpa LGA. Separately, four were reportedly killed during a clash between Nsobo community in Obubra LGA, Cross River, and Ofunakpa Inyimagu community in Ikwo LGA, Ebonyi state. In July, eighteen were reportedly killed during a communal clash over a land dispute between Wanikade and Wanhimen communities in Yala LGA. In August, a primary school teacher was reportedly shot dead during a clash between Bette community in Obubra LGA, Cross River and Tiv communities in Vandeikya LGA, Benue state. Separately, tension was reportedly elevated over a land dispute in Biase LGA. Five communities allegedly teamed up and attacked another community over a disputed land.

reportedly shot dead in his shop by robbers in Calabar South LGA. In July, five robbers were reportedly killed in a gun duel with the police in Calabar South after stealing a man's money as he stepped out of a bank. Separately, a former staff of the National Assembly was reportedly shot dead during a gun duel between the police and his kidnappers in Calabar Municipal. In a separate incident, a senior immigration officer was reportedly killed by robbers on his way from a night club in Calabar South. In August, a village head was reportedly killed in his residence in Bakassi LGA. The victim was a staff member of the audit department of the Cross River state Ministry of Finance. Separately, an 18-month old girl was reportedly killed for ritualistic purposes in Calabar South. The severed heart of the victim was reportedly found in a church.

<u>Gang/Cult Violence</u>: In June, six were reportedly killed in a supremacy battle between Italian and Vikings cult groups in Calabar South LGA. Separately, two were reported killed in a clash between Black Axe and Vikings confraternities at the palace of a traditional ruler in Yakurr LGA. In another incident, five were reportedly killed in a clash between Vikings and KKK cult groups in Ogoja LGA. In August, suspected cultist was reportedly shot dead by members of a rival cult group in Calabar South.

Other Incidents: In June, three suspects were reportedly lynched by a mob in Calabar Municipal after allegedly stealing a mobile phone belonging to a woman. In July, one person was reportedly killed during a clash between a group of militants and soldiers in Calabar South LGA. Separately, eleven were reportedly killed and several others injured during a fire outbreak in Calabar Municipal. The inferno was allegedly caused by the activities of illegal dealers in petroleum products.

<u>Natural Disaster</u>: During the month, several communities in the state were ravaged by flooding following days of heavy rainfall. In Boki LGA, over 12 communities were devastated by flood which destroyed over three thousand farmlands and hundreds rendered homeless.

## Prognosis


Incidents during the period included communal conflict, criminality, militancy, protests, cult and mob violence. Peace Actors in the state should monitor the situation closely and respond appropriately.
