BACKGROUND

The Foundation for Partnerships Initiatives in the Niger Delta (PIND Foundation) is a Nigerian nonprofit organization established in 2010 with initial funding from Chevron Corporation to promote peace and equitable economic growth in Nigeria's Niger Deltaregion by forging multi-sectoral and multi-stakeholder partnerships at the regional, national and international levels. To achieve our mission, we work closely with numerous partners to implement collaborative marketbased, community-owned programs to mitigate conflicts and boost economic opportunities for local businesses, ensuring that economic progress occurs in a systemic, inclusive and sustainable manner.

With an overarching goal of increasing income and employment in the region, the Foundation has two distinct but interrelated program areas, and enablers. They are:

- An economic development (ED) program focused on generating opportunities for propoor market development and employment generation.
- A peace-building (PB) program that strengthens conflict resolution mechanisms for enabling integrated peace and economic growth
- The enablers: PIND's program delivery is enabled by an integrated approach that encompasses capacity building, advocacy, communications, gender, and social inclusion.

PIND's Planning, Monitoring and Evaluation department supports managers of these programs to develop periodic plans, measure changes and ensure accountability.
