

Executive Director's Message

Delivering Impact, Empowering Communities

eflecting on 2024, I am immensely proud of the transformative impact PIND has achieved through our partnerships, innovative programs, and dedicated team. This year was a testament to what can be accomplished when people work together to foster peace and prosperity.

Working through commercial service providers and local market actors, our Market Systems Development (MSD) program has enhanced farmers' and enterprises' knowledge, attitudes, and practices (KAP). These interventions have led to significant economic outcomes, including increased incomes exceeding N132 billion. Stories like that of Amunega Zekeri, who transitioned from a teacher to a thriving cassava farmer and service provider, highlight the ripple effect of these efforts. With PIND's support, Amunega not only improved his own livelihood but also equipped other farmers with improved techniques, transforming agricultural practices in his community.

Our Youth Employment Pathways (YEP) program also achieved remarkable outcomes, equipping over 1,450 youth with market-relevant skills. Among them is Chidera Endurance John, who transitioned from minimal digital literacy to securing a digital marketing role that expanded his career opportunities and improved his income.

PIND's Access to Energy (A2E) program made significant strides, helping communities save an estimated N4.43billion in energy costs. In Ogidigben and Okibou-Zion, solar refrigeration hubs enabled over 500 fisherfolk and MSMEs to produce, preserve, reduce losses, and expand their businesses — improving livelihoods in previously underserved communities.

Our commitment to peacebuilding continued to deliver tangible results. In 2024, we trained 458 new peace actors, who applied their skills to prevent and resolve disputes. More than 510,000 people across 66 communities reported improved safety and stability as a result of these efforts.



None of these accomplishments would have been possible without the dedication of our incredible staff, who worked tirelessly to engage communities, train farmers, and support peace actors. Likewise, our partnerships with local organizations, government agencies, and donors have been pivotal in driving lasting change.

As we transition into Phase IV of our strategic journey, we remain committed to scaling impactful solutions, strengthening community resilience, and empowering more individuals to build prosperous futures.

I extend my deepest gratitude to our partners, donors, and the entire PIND team for their dedication to our mission. Together, we are building a stronger, more resilient Niger Delta.

Since our establishment in 2010, we have worked to reduce poverty and conflict in the region by fostering partnerships that drive systemic change.

We believe sustainable development thrives when communities have the right tools, resources, and knowledge. By supporting smallholder farmers, youth, and entrepreneurs, we create opportunities for improved livelihoods and economic stability. Our work extends beyond immediate solutions — we focus on building resilient systems that deliver lasting impact.

By building partnerships and leveraging data-driven interventions, PIND strengthens systems that foster lasting change in the Niger Delta.

What We Do

PIND employs a holistic approach that combines economic development, peacebuilding, and advocacy to improve livelihoods and promote stability in the Niger Delta. Our initiatives empower smallholder farmers, youth, women, persons with disabilities, and entrepreneurs by enhancing access to markets, skills, finance, and clean energy solutions.

We ensure local ownership and long-term sustainability through partnerships with community organizations, government institutions, and the private sector. By integrating conflict prevention strategies, we help communities resolve disputes proactively, fostering peaceful coexistence


Our interventions are designed to scale and adapt, ensuring they remain relevant to the region's evolving needs.

Where We Work

PIND operates across the nine states of the Niger Delta: Abia, Akwa Ibom, Bayelsa, Cross River, Delta, Edo, Imo, Ondo, and Rivers.

With offices in Abuja, Warri, and Port Harcourt, we are strategically positioned to support grassroots organizations, engage stakeholders, and deliver impactful programs that address the region's most pressing challenges.

Our localized presence enables us to understand community dynamics, build trust, and deliver solutions responsive to the needs of the people we serve.



Our Capacity

In 2023

- Despite economic challenges and rising inflation, PIND made significant strides in empowering farmers, businesses, and youth across the Niger Delta. Through our Market Systems Development (MSD) program, we supported over 65,400 farmers and MSMEs with improved agronomic practices, achieving a 94% completion rate against our 2023 outreach target. Farmers and MSMEs invested N12.48 billion in improved practices, surpassing expectations.
- Our Youth Employment Pathways (YEP) program empowered over 2,100 youths with applicable skills, with over 1,800 participants gaining access to income-generating opportunities a remarkable 135% achievement against the 2023 annual target.
- In our Access to Energy (A2E) program, our innovative partnerships extended clean energy solutions to 12 communities, powering healthcare centers, households, and businesses. This initiative

- displaced over 890.4 metric tons of CO equivalent (tCO e) emissions and generated 1.6 million kWh of clean energy.
- PIND's peacebuilding efforts successfully mitigated violent incidents in key Niger Delta communities, with 300+ peace actors resolving emerging conflicts and 655 stakeholders actively utilizing PIND's conflict data products.

In 2024

- Moved into new offices in Abuja and Port Harcourt, added three key team members in Human Resources, Program Support Services, and Knowledge Management & Communications.
- Scaled our achievements to expand our impact. By Q4, our MSD program reached over 101,800 farmers and MSMEs, surpassing our annual target by 20%. Adoption of improved practices climbed to 82%, contributing to a cumulative investment of N21.01 billion and generating N38.78 billion in additional income.

- Our YEP program recorded over 1,450 graduates, with 84% securing livelihoods through employment or entrepreneurship. Challenge Fund grants disbursed N67 million to 114 beneficiaries, with over half being women-owned businesses.
- In the A2E program, solar-powered refrigeration hubs in Ogidigben and Okibou-Zion supported over 500 fisherfolk, MSMEs, and households, reducing post-harvest losses and improving access to medical services.
- PIND's peacebuilding program saw increased engagement, with 2,570 stakeholders and community-based organizations leading localized peace interventions utilizing conflict early warning data.

Looking ahead to 2025, PIND will expand its reach with ambitious goals to:

- Increase outreach in MSD to support 120,000 farmers and MSMEs in adopting improved practices.
- Equip 2,500 youths with technical, entrepreneurial, and soft skills, ensuring at least 1,800 secure income-generating opportunities.
- Establish additional solar-powered hubs in underserved communities to power businesses, healthcare, and homes.
- Strengthen our peacebuilding infrastructure by expanding community conflict prevention initiatives across the Niger Delta.
- Deepen partnerships with donor agencies and private sector players to secure sustainable funding that scales our impact.

Through these initiatives, PIND will continue to drive inclusive economic growth, build resilient communities, and strengthen peace in the Niger Delta.

Peacebuilding 2024 Achievements

Fostering Peace And Stability

PIND's peacebuilding efforts in 2024 reached 2,570 stakeholders, surpassing the annual target by over 100%. Through the Early Warning and Early Response (EWER) system, in 2024, PIND produced and disseminated 54 peacebuilding data products, including 49 weekly briefs, three quarterly conflict trackers, one policy brief, and one annual conflict report, providing actionable insights to local, national, and international peace actors.

To expand grassroots peacebuilding interventions, PIND awarded grants to nine Community-Based Organizations (CBOs) across the Niger Delta, empowering them to implement tailored peace initiatives. Notably, the Sanab Development Foundation led a successful Violence Against Women and Girls (VAWG) awareness campaign in Umudike, Abia State, engaging students, university officials, and traditional leaders to address intimate partner violence risks.

PIND also strengthened its Prevent Councils, expanding into Abia, Edo, and Ondo States to

improve early warning systems, foster collaboration with traditional rulers, and promote proactive conflict resolution.

Through its Partners for Peace (P4P) network, over 1,200 peace actors successfully resolved conflicts using 139 quality actions in 2024 alone. Additionally, over 510,000 people across 66 communities in the Niger Delta reported improved safety and security in their communities.

In Bayelsa, PIND's P4P network helped mitigate recurring clashes between farmers and herders in the Igbogene and Nyambiri Zarama communities by facilitating multi-stakeholder engagements that resulted in the establishment of a Conflict Monitoring Group to track and manage disputes.

PIND's peacebuilding initiatives, including cultural and arts-based activities that engaged over 1,600 participants, continue to drive meaningful change, fostering safer and more resilient communities across the Niger Delta.

Dr. Agboro's shift from reactive conflict response to proactive peacebuilding exemplifies PIND's peacebuilding success. His leadership in mediating community disputes has reduced violence and strengthened social cohesion.



"Before meeting PIND, my conflict resolution approach was reactive, focusing only on disputes after they escalated. PIND shifted my perspective, teaching me that preventing conflict is more effective than managing it. Since 2010, I have worked on mitigating farmerherder clashes and

community disputes, and in 2022, I became Chairman of Non-State Actors in Delta State. With PIND's support, we successfully mediated land disputes and now use the Early Warning Early Response (EWER) system to track and address conflicts proactively, ensuring peacebuilding remains a priority in our communities." – **Dr. Agboro**



Economic Development 2024 Achievements



Driving Inclusive Agricultural Growth

In 2024, PIND's MSD program empowered over 101,825 farmers and MSMEs, exceeding the annual target by 20%. Farmers adopted improved agronomic practices, resulting in investments of

N21.01 billion — 152.4% above the target of N13.78 billion.

This adoption led to significant financial gains, with farmers and MSMEs generating N38.78 billion in additional income, surpassing the annual

target of N21.15 billion by 183%. The program also created 22,544 full-time equivalent (FTE) jobs, exceeding the target of 13,000 by 173%.

In partnership with Newland Pathways Integrated Consult and Marich Agro Allied Services, PIND supported 1,145 micro-businesses in Ondo and Delta states, equipping fisherfolk and coastal entrepreneurs with improved skills and technologies. As a result:

- 272 fisherfolk were trained in improved fishing practices, boosting productivity.
- N3.05 million in market linkages was facilitated, connecting fisherfolk to broader financing and trade opportunities.
- 67 improved fishing technologies were adopted in coastal communities, reducing post-harvest losses and enhancing incomes.

- Cassava Farming and Service Provision

Amunega's journey from a classroom teacher to a thriving cassava farmer and farm service provider reflects the impact of PIND's MSD interventions. With improved techniques and tools, Amunega trains rural farmers, enhancing their productivity and incomes.



"Before 2024, I was a classroom teacher without knowledge of cassava farming. PIND's training helped me establish a four-plot cassava farm, equipping smallholder farmers with improved techniques to boost their productivity. In Obi Ayaga, Delta State, my guidance significantly improved farmers' yields and incomes, earning praise from community leaders. Inspired by this impact, I remain committed to expanding my reach, introducing improved practices, and empowering more communities across the Niger Delta." – Zekeri



Expanding Clean Energy Solutions For Growth

PIND's Access to Energy (A2E) program delivered transformative clean energy solutions to underserved communities. In 2024, solar-powered refrigeration hubs, each powered by 15kWp solar systems, were deployed in Ogidigben and Okibou-Zion (Delta State).

These hubs supported over 500 fisherfolk, MSMEs, and households, significantly reducing post-harvest losses by up to 40% and improving economic activities. The refrigeration hubs preserved over 1.2 metric tons of fish weekly, improving product quality and increasing market value.

The hubs also enhanced healthcare services by providing stable electricity for medical storage and treatments. In collaboration with community leaders, PIND facilitated N5.8 million in local contributions to support hub maintenance, ensuring sustainability.

PIND's A2E program deepened engagement with Host Community Development Trusts (HCDTs), strengthening partnerships to align energy initiatives with broader development plans. PIND ensured long-term impact and improved energy access for underserved populations by integrating solar solutions into community-driven projects.

Patrick was key in supporting PIND's solar power intervention in Bateren. The community transitioned from unstable generators to solar power, improving the quality of life and business efficiency.



"For years, the Bateren community faced unreliable electricity, relying on costly diesel generators that failed during a local crisis. In 2024, PIND introduced a solar energy project that the community manages and sustains. This intervention transformed lives -households now enjoy stable power, children can

study at night, and businesses operate more efficiently. More than just providing light, the project fostered unity and a sense of ownership within the community" – **Awanebi**



Equipping Youth For Future Opportunities

In 2024, PIND's YEP program trained 1,454 youth, of which 84% successfully secured employment or started businesses. 1,223 graduates reported increased earnings after training, demonstrating tangible economic impact.

The program facilitated N67 million YEP Business Start-up Challenge Fund grants for 114 businesses, including 60 women-owned and five PWD-led enterprises. These businesses spanned key sectors such as agriculture, construction, ICT, and services, enhancing their growth and sustainability.

Additionally, 294 youth were placed in internships and apprenticeships, enabling them to refine their skills and improve employability.

Through PIND's YEP program, John transitioned from having limited digital skills to becoming a successful social media marketer. The program empowered her to secure internships, launch her salon business, and grow her digital marketing career.



"I came in contact with the YEP Project in 2023 after receiving the flyer for training from a friend. Before the Project, I only knew how to transfer files from my phone to my laptop and vice versa. The training helped me improve my digital literacy skills and become a social media marketer. Since the training. I have received

various opportunities, such as being selected for the first stage of the Outreach Internship cohort program. I have also worked as a Digital Marketing Executive at The Curtwriters. The YEP training helped me improve my income and gave me skills to grow my online presence and enhance visibility for my hair salon business I started." - John





Capacity Building, Advocacy, Gender Equality and Social Inclusion (GESI) and Business Development 2024 Achievements

Strengthening Skills For Greater Impact

PIND strengthened four HCDTs (Warri Kingdom Coastal, Egbema-OPUDIS, Agbonu Ogulaghalbe, and Ugboland) with training in conflict resolution, stakeholder engagement, and governance. These initiatives ensured improved community project delivery and fostered a culture of peace.

PIND also supported organizations like GREENCODE, which secured N46 million in grants to implement development initiatives, including:

- The MoCCSA Project, strengthening citizen engagement for social accountability.
- The Tax Justice & Governance Project, advocating for transparent tax reforms in the Niger Delta.

With PIND's support, Mrs. Eze-Owenz trained over 600 individuals, linked 103 to finance, and mentored small businesses to expand their reach and improve operations.



"As a farmer and agro dealer, I was passionate a bout supporting smallholder farmers but lacked the platform to expand my impact. That changed in April 2024 when I became a PIND-trained Business Service Provider (BSP). Since then, I have supported over 600 beneficiaries, linked 103 individuals to finance, and

provided business development training. With PIND's support, I now equip entrepreneurs with the tools to grow their businesses and remain committed to driving sustainable impact." – Eze-Owenz

Driving Policy Reforms And Strengthening Partnerships

PIND's advocacy efforts in Q4 2024 advanced key policy reforms, strengthened government engagement, and supported sustainable development initiatives across the Niger Delta.

PIND collaborated with arable land committees in Edo and Ondo States to enhance land access for smallholder farmers and promote inclusive land policies. In Ondo State, PIND partnered with the Ministry of Agriculture to finalize a land access policy draft, which is now awaiting the governor's assent. These efforts align with broader initiatives such as FAO's FOLUR-IP project and the Mastercard Foundation's agricultural interventions.

PIND also tackled the issue of multiple taxation and illegal levies affecting small businesses in the Niger Delta. A landmark report highlighting these challenges was published, followed by a Regional Tax Reform Dialogue involving key stakeholders such as the Tax Justice & Governance Platform, SMEDAN, and the Port Harcourt & Aba Chambers of Commerce. As a result, a Technical Working Group (TWG) was established to advocate for tax policy reforms, aligning with national and regional economic strategies aimed at ensuring a suitable environment for the sustainability of micro, small, and medium Enterprises

In Q4 2024, PIND strengthened its engagement with youth-focused agencies by participating in the 7th National Council on Youth Development (NCYD). This collaboration led to opportunities for apprenticeship programs, adopting the Youth Employment Pathways" (YEP) model across the region.

Under the Petroleum Industry Act (PIA) Bridges Project, PIND facilitated capacity-building workshops for Host Community Development Trusts (HCDTs) to improve governance, project sustainability, conflict resolution, and data management practices. The engagement also involved pitching energy solutions and development interventions to ensure sustainable community growth. PIND secured approval to

transition the Bridges Project into a state-level MSP model with enhanced CSO participation for long-term sustainability.

Through these targeted efforts, PIND continues to influence policies, strengthen partnerships, and promote inclusive development to drive positive change in the Niger Delta.

Promoting Inclusive Growth

In 2024, PIND empowered 50,103 women, representing 48% of total program beneficiaries, surpassing the annual target of 40% female participation.

Through targeted interventions, PIND trained 29 persons with disabilities (PWDs) in technical skills under the YEP program, while 376 women actively participated in conflict prevention and peacebuilding initiatives.

PIND's GESI program empowered Oguadimma to train over 2,000 women, youth, and persons with disabilities in conflict mitigation, peacebuilding, and economic empowerment.



"Before 2021, financial constraints limited my organization's ability to scale its impact. Partnering with PIND's Gender and Social Inclusion (GESI) program changed that, enabling us to train over 2,000 women, youth, and Persons with Disabilities (PWDs) in conflict prevention and peacebuilding strategies.

Drawing from my experience with PIND's Partners for Peace (P4P) network, I now mentor others, expanding peace clubs and empowering youth with skills to choose livelihoods over violence. Together, we are building a stronger, more resilient Niger Delta." – **Oguadimma**

Expanding Partnerships And Investments

In 2024, PIND exceeded its Phase III fundraising target by securing a \$6.249 million grant from the Mastercard Foundation for the Youth Cassava Aggregation Project (YCAP). This multi-year investment will significantly scale PIND's impact in agriculture and youth empowerment across the Niger Delta. The partnership will expand access to technical and vocational training, improve access to agricultural technologies, and strengthen market linkages for cassava farmers—further reinforcing PIND's role as a leader in systems-based development programming.

Another major milestone in 2024, one of PIND's most significant achievements was the formalization of a partnership with Okomu Oil Palm Company PLC (OOPC), a major private sector player in Edo State, through the signing of a Memorandum of Understanding (MoU). This milestone not only underscored PIND's role as a trusted technical partner in the region but also demonstrated the successful operationalization

of the Foundation's peacebuilding-economic development nexus model.

The partnership enables PIND to support Okomu Oil Palm Company's corporate social responsibility (CSR) initiatives through:

- A Community Needs Assessment (CNA) and
- the development of a Community Development Plan (CDP)
 - Capacity-building workshops on conflict prevention and stakeholder engagement
- Co-designed interventions in agriculture, youth employment, renewable energy, and finance.

This engagement also generated new revenue for PIND and demonstrated the value of its technical models for community development. A joint steering committee has been established to guide implementation and ensure community participation.

This collaboration exemplifies PIND's approach to peace-impact investing and stands as a replicable model for partnership-driven transformation in the Niger Delta.









Interning At Pind

At PIND, we believe in nurturing the next generation of leaders by providing hands-on learning opportunities that equip interns with essential skills for career growth. Our internship program offers a dynamic platform for young professionals to gain practical experience, enhance technical expertise, and develop leadership abilities.

In 2024, our interns played active roles across departments, gaining insights into peacebuilding, finance, stakeholder engagement, and organizational operations. With mentorship at the core of the experience, our interns contributed meaningfully to PIND's work while developing skills that will shape their future careers.








LESSON LEARNED

Market Systems Development (MSD)

Enhancing Inclusivity in Commercial Seed Production for Cassava Seed Entrepreneurs (CSEs)

The 5-hectare land requirement set by Umudike Seeds for Cassava Seed Entrepreneurs (CSEs) aiming to engage in commercial seed production has proven to be a significant barrier for some CSEs, given the limited land availability in the Niger Delta.

Key Takeaway:

By adopting a scalable model that reduces the land requirement to 0.5 hectares with access to increase to 3 hectares, PIND can promote greater inclusivity, increase participation, and expand the region's seed production base.

Communications

Strengthening Engagement

While PIND's digital presence has grown, there is a need to expand visibility beyond social media, especially as PIND enters Phase IV, refreshes its brand, and celebrates its 15th anniversary.

Key Takeaway:

PIND's Communications Unit is enhancing its media engagement strategy to prioritize mainstream media coverage and paid promotions to ensure broader visibility and sustained public awareness.

LOOKING AHEAD: PIND'S STRATEGIC OUTLOOK FOR 2025 AND BEYOND

Moving into Phase IV (2025–2029), PIND aims to scale its impact through systemic transformation and sustained resilience, guided by a renewed strategy that champions inclusive economic growth, deepened peacebuilding efforts, and strategic partnerships for long-term development in the Niger Delta.

Embracing a New Phase of Growth

In 2025, PIND will embark on a transformative journey guided by the theme: "Deepening Impact through Systemic Changes and Resilience." This next phase will prioritize sustainable solutions that address the region's socio-economic challenges, ensuring long-term benefits for communities, farmers, MSMEs, and peace actors.

Strategic Objectives for Phase IV

SO1: Better functioning market systems: for agricultural and MSME sectors; youth skills development for employment; finance, and access to renewable energy which are benefiting 800,000 farmers and MSMEs, 50% of whom will increase their income by 40%; the creation of 150,000 new jobs of which 50% will be youths and other vulnerable groups; and 250 communities electrified.

SO2: Investment by donors/funders influenced by PIND in Niger Delta (\$50million): Funds from donor/funders influenced by PIND into the region; funds raised for PIND managed activities (Raise additional funds from private sector and donor community for PIND programs. A minimum of \$7.5 million raised for PIND, equivalent to 30% of Chevron's funding).

SO3: Integration of climate adaptation and mitigation initiatives to increase resilience in the Niger Delta:

Stimulate the market for carbon credits in the Niger Delta (value generated from mangroves, plantations, etc.) Reduction of GHG Emission from renewable energy; Mitigation plans on negative impact of flooding through community plans (Peacebuilding and MSD); Numbers of enterprises

selling bio/organic products, value of sales.

SO4: HCDTs are co-investing in their priority projects to improve economic and peace agendas in their communities: Enhance the capacity of Host Community Development Trusts (HCDTs), to co-design and co-invest in interventions to stimulate skills development, linkages to markets, and renewable solutions for job creation and income generation in their communities.

SO5: Reducing conflict and promoting peace: ensuring a sustainable and effective deployment of P4P Network; cultivating linkage between Peace Building and Economic Development; delivering value to Chevron; and addressing regional conflict issues.

Key Focus Areas for 2025

PIND's Phase IV strategy will adopt seven key priorities to drive impact:

1. Strengthening Host Community Development Trusts (HCDTs):

PIND will strengthen its partnerships with Host Community Development Trusts (HCDTs) to promote community-led development, ensuring Chevron's social investment programs align with broader community development goals.

2. Scaling Market Systems for Economic Growth:

PIND will expand interventions in agriculture, MSME development, and youth employment. Key focus areas include enhancing technical support for farmers, expanding access to finance through initiatives like Sombreiro Kapital, and strengthening partnerships with renewable energy providers.

3. Strengthening Peacebuilding Efforts:

Building on successful interventions in conflictprone areas, PIND will elevate grassroots peacebuilding activities to regional platforms. The focus will be on equipping stakeholders with skills to mitigate conflicts and enhance early warning systems.

4. Enhanced Results Measurement and Storytelling:

PIND will improve data-driven reporting to capture and showcase outcomes from its

programs. This will involve refining impact assessment methods and using storytelling to communicate PIND's transformative impact.

5. Deepening Government Engagement:

PIND will expand its advocacy efforts, aligning with national priorities to influence policy reforms that promote peace and economic development. Strategic engagement with regulatory bodies will accelerate progress in implementing the Petroleum Industry Act (PIA).

6. Attracting More Investments to Scale Impact:

PIND will actively seek funding from impact investors, donors, and the private sector to sustain its programs. Continuum Capital, PIND's impact investment vehicle, will be instrumental in mobilizing resources for development projects.

7. Integrating Climate Resilience:

Climate-smart strategies will be embedded in all PIND interventions to protect vulnerable communities from environmental risks and ensure economic resilience.

Expanding Key Interventions In 2025

Key initiatives that will shape PIND's impact in 2025 include:

- Peacebuilding Strategy Expansion: PIND will expand the Niger Delta Regional Peacebuilding Strategy (NDRPS) to include wider collaborations with security agencies, CSOs, and traditional rulers for sustained peace.
- Energy Access Innovation: Building on the success of community energy solutions in 2024, PIND will expand its Access to Energy (A2E) program to reach more underserved coastal and non-coastal communities.

Strengthening Organizational Sustainability

In 2025, PIND will adopt a refined governance model, improve internal capacity, and strengthen donor relations to maintain growth momentum. With enhanced fundraising strategies and impactful storytelling, PIND will continue to secure the resources needed to sustain its programs.

With a strategic focus on innovation, resilience, and collaboration, PIND's Phase IV strategy is

designed to expand its impact, empower communities, and promote sustainable development. By leveraging partnerships, scaling proven models, and embracing systemic change, PIND will continue to build a more peaceful, prosperous, and resilient Niger Delta.
