
Niger Delta Weekly: Mitigating Violence Against Women and Girls in Ondo State

February 11-17, 2024

Background

This edition of the weekly update spotlights gender-based violence (GBV) in the Niger Delta with a focus on violence against women and girls (VAWG) in Ondo State. VAWG is a major threat to peace and human security in Ondo State. According to data (see map below), more than 80 incidents of VAWG and over 35 related fatalities were reported in the State between January 2021 and December 2023. Recent data shows an increase in reported incidents of violence against women and girls including sexual violation, domestic violence and targeted killing. In January 2024, for instance, a 55-year-old woman was allegedly raped and killed by a 35-year-old man in Ilere community, Akure South LGA. In February, a 20-year-old female student was reportedly killed by a 21-year-old male student during a disagreement in Akungba-Akoko community, Akoko South-West LGA. More recently, on February 09, 2024, a popular businessman allegedly macheted his wife to death during a disagreement over a private matter at their residence in Alagbaka community in Akure the Ondo State capital. The man reportedly later committed suicide.

Why it Matters

The prevalence of violence against women and girls is a serious threat to public health, communal stability, socio-economic development and human security in the State. If not mitigated, the situation could intensify in ways that could reinforce harmful cultural beliefs and practices that could further undermine the human rights, health and safety of women and girls. Moreover, when VAWG is overlooked, it could embolden perpetrators to commit more violence and this can engender a general feeling of injustice in the society.

Anticipated Trends and Dynamics

Violence against women and girls is a major threat to economic development and human security in the State. Stakeholders should collaborate with the relevant government and non-governmental agencies to address the underlying drivers and develop appropriate remedial, punitive and preventive measures, including awareness raising to transform attitudes and behaviors that condone VAWG. Awareness raising and engagement of traditional institutions and civil society organizations could help mitigate VAWG in the State.
